While the online application is the primary method for enrollment you still have options to find information on plans and enroll for coverage.

Ready to Apply and Enroll? Here are step-by-step instructions for each application and enrollment option



Online

Fill out an application & enroll at healthcare.gov

Step 1: Get your personal and family information organized by using the worksheet on the next page

Step 2: Set up an online account on healthcare.gov. Provide basic information. Then choose a user name, password, and security questions for added protection

Step 3: Fill out the online application. You'll provide personal information about your family

Step 4: Compare your options. You'll be able to see all the options you qualify for, including private insurance plans. You'll see details on costs and benefits to help you choose a plan that's right for you

Step 5: Enroll. After you choose a plan, you can enroll online and decide how you pay your premiums to your insurance company



Phone

Call the HealthCare.gov call center at **1-800-318-2596**

Step 1: If you are having difficulty using the online application, or wish to apply and enroll over the phone, get your information organized

Step 2: Call **1-800-318-2596**

Step 3: If the operator tells you that they cannot help you because you are from Idaho tell them that Idaho is using the federal application and they can help you

Step 4: If you are still having trouble ask to speak to a supervisor

REMINDER: The call center cannot set up online accounts



Paper Application

Fill out and mail in a paper application available for download on **YourHealthIdaho.org**

Step 1: When filling out the application if possible supply an email address and indicate desire to receive an email notification to speed up the eligibility determination process

Step 3: In Appendix C enter information from your agent and broker including their NPN number

Step 4: Mail in the paper application to: Health Insurance Marketplace, Dept. of Health and Human Services, 465 Industrial Blvd, London, KY 40750-0001

Step 5: Once application is received it should be processed in 3-5 business days (note: process may be longer if the application is incomplete or has errors)

Step 6: Once application is processed, consumer will receive a notice in the mail and can create an account on healthcare.gov, enter the application ID from the notice in the mail and continue to shop, compare and choose a plan
